I4M Overview



- The Innovation for Machinery (I4M) funding scheme provides SME businesses in Greater Manchester (GM) and West Yorkshire (WY) with access to advanced machinery* expertise to accelerate the development of the next generation of machinery and create new jobs and growth in this sector.
- I4M aims to encourage the development of new manufacturing technology and capabilities within advanced machinery, robotics, automation, or associated industries:
- This scheme is managed by the National Physical Laboratory (NPL) on behalf of the AMPI and funded through UKRI's Strength in Places Fund.
- The scheme is designed to remove the barriers to innovation funding for SMEs±.

Notes:

- * Advanced machinery refers to technologically advanced equipment and systems used for manufacturing, production, and other complex operations. These machines incorporate innovative technologies to improve efficiency, accuracy, productivity, flexibility, and safety in industrial processes.


Project Types

Projects must focus on delivering advancements in <u>machinery for manufacturing</u>.

Not sure if your idea is within scope?

We recognise that it is often difficult to demonstrate significant regional impact in the earlier stages of R&D, so we assess each application on a case-by-case basis and can provide upfront steer and support prior to submission.

Breadth of Application Scope



Target machinery industries could include:

- Machine tool manufacturers
- Robotics manufacturers
- Other machine* manufacturers
- Machine control system manufacturers
- Providers of digitalisation systems for manufacturing, including sensing and control
- Machinery subsystems manufacturers
- Automation system manufacturers

Target technologies for machinery could include:

- Machine tool, robotic, and automation systems
- Advanced controllers and PLCs
- In-situ and in-process measurement systems
- · Intelligent software systems
- On-machine sensor networks
- True digital twins of machinery
- Hybrid and reconfigurable systems
- Sustainable† machine development
 - † Environmentally sustainable e.g., circular processes, recycling etc.

In addition to technical courses relating to columns one and two, courses for machinery upskilling could include:

- · Technical project management
- Risk management
- Engineering management
- Product management
- IP and exploitation
- Conformity assessment (e.g. UKCA, CE, ATEX)



Funding Streams Available



Stream 1: Research Route

- Projects must have a total funding request of no more than £50,000.
- The project 'deliverer' (research institution) will supply a project proposal and costings following application approval.
- Funds will be issued at the end of the project upon receipt of a final project report and participation in an impact interview.

Stream 2: Consultancy Route

- Projects must have a total funding request of no more than £10,000 (excluding VAT).
- Funding is provided on a 50% match funded basis, therefore if your total projects costs are £20,000 then I4M will reimburse £10,000.
- Funds will be issued at the end of the project upon receipt of a valid invoice and final project report.

Stream 3: Training Route

- Training must have a total funding request of no more than £10,000 per organisation, maximum of two people (excluding VAT, so I4M will pay up to £5,000 per person).
- Funds will be issued at the end of the training upon receipt of a valid invoice and Certificate of Completion.

Projects must focus on delivering advancements in **machinery for manufacturing**.



Eligibility for all funding streams



Projects must:

- Be a UK registered SME with significant technical operations based within the Greater Manchester or West Yorkshire regions
- Start within three months following approval and last between three to six months
- Carry out its project work within the Greater Manchester or West Yorkshire regions (see Appendix A)
- Intend to exploit the results from or in the UK
- Be within your Minimal Financial Assistance (MFA) limit
- Involve at least one university based in the Greater Manchester and West Yorkshire regions
- End by 30 June 2026

Additional eligibility for all streams:

- Your project can include partners that do not receive any of this scheme's funding, for example businesses outside of the defined regions.
- Suppliers can be from anywhere in the UK and you must select them through your usual procurement process.
- A business can only lead on one application per stream.
- Unsuccessful applicants are permitted to make one further application per stream. Feedback will be provided to support re-applications.



Additional Eligibility for Research Route (stream 1)



Projects must have a total funding request of **no more than £50,000**. The project 'deliverer' (research institution) will supply a project proposal and costings following application approval.

Additional eligibility for <u>stream 1 only</u>:

- Non-Time Costs are limited to 20% of total project costs. Non-time costs include subcontracting, materials, equipment, and T&S.
- Subcontractors can be from anywhere in the UK and you must select them through your usual procurement process. All subcontractor costs must be justified and appropriate to the total project costs.
- A university can collaborate on any number of applications but cannot lead or work alone



Additional Eligibility for Training Route (stream 3)



Training must have a total funding request of no more than £10,000 per organisation, maximum of two people (excluding Vat, so I4M will pay up to £5,000 per person).

Funds will be issued at the end of the training upon receipt of a valid invoice and Certificate of Completion.

Additional eligibility for <u>stream 3 only</u>:

 If the selected training is not available within three months, a revised timeline can be agreed directly with the I4M Lead.



Out of Scope



We will **not** fund projects that:

- are outside of the Greater Manchester and West Yorkshire regions
- do not meet the eligibility or scope
- are not industry-defined
- do not collaborate with a university/NPL based inside the Greater Manchester and West Yorkshire regions (relevant for Stream 1 only)
- are capital expenditure or infrastructure projects



Key Information



- This is an assessed process with a defined budget; therefore, funding is not guaranteed. All applications will be assessed by a triage committee.
- Should a company require support in developing their project, submitting their application, or finding a collaboration or service/training provider, AMPI will support.
- All applications must be made through the <u>I4M</u>
 <u>portal on the AMPI website</u>. Please read the full
 scope and eligibility criteria on the website before
 applying.

Appendix B: What to expect...



Although projects should last between 3-6 months, an I4M project is a ~12-month commitment

Application

- Determine suitable research partner/service provider/training provider
- Clarify project/consultancy/trainin g scope with research partner
- Contact the I4M Lead if you have any questions about the suitability of a project.
- Draft, and submit, application via the I4M portal

Triage

- Decisions are made once a week every Friday.
- If an application is submitted on a Friday, it will be reviewed the following week.
- I4M Lead will communicate decision and next steps required to progress with your project.

Pre-Kick Off

- •For all funding streams we require a signed Minimal Financial Assistance (MFA) Statement.
- Research and Consultancy projects are required to submit a project proposal and costings prior to project kick off.
- For approved Training applications, no additional steps are required.

Delivery

- Once the I4M Lead confirms the funding offer (via an award letter), the project can be kicked off.
- I4M Lead to be invited to the project kick off and subsequent progress meetings for Research projects.
- Project change requests must be raised with the I4M Lead.

Closure

- Upon project closure, industrial and academic contacts will be asked to participate in an impact survey. This is a requirement across all streams.
- •The I4M Lead will arrange a time to hold an interview to capture the essence of the project to develop a case study. (Note: the depth of these will be determined by the project output and industry lead comfort).
